Clean-Down & Biosecurity Technician

The activities carried out at the facility include work on various aquatic organism, record keeping, and cleaning of facility and laboratory spaces; the candidate would be partially involved in aspects of the daily operations as well as being involved in specific research assignments.


Synopsis of position offered

This position is only open for EU/EEA/UK passport holders or TCNs presently residing in the EU with the required permits.

A position within the AquaBioTech Group has arisen for a suitably qualified person to work as a Clean-Down & Biosecurity Technician at our R&D facility known as **ABT Innovia**. The responsibilities of the selected candidate are defined as follows: -

- Cleaning of Facility and Laboratories spaces within ABT Innovia, following safety and biosecurity protocols
- Cleaning and Disinfecting tanks and filtration systems within the facility
- Properly maintaining walkways and work areas clean including floors, corridors and drains
- Assume responsibility of waste management within ABT Innovia facility

Qualifications and Experience Overview
