Overview of associated tasks

Qualifications & Knowledge

The ideal candidate will have a strong balance between academic qualifications and practical experience in the field of aquaculture. The individual is expected to have a DVM, Doctorate of Veterinarian Medicine.

Experience in laboratory operating procedures, GMP for the Batch Release of Aquatic Vaccines and GLP would also be a bonus, but not essential as all training in these procedures will be provided.

The selected candidate will have to speak and write English fluently. Knowledge of any other languages would be considered an asset, although not essential.

The selected candidate must have a clean EU / EEA passport OR be a third-country national (TCN) presently residing in the EU with no travel restrictions or legal convictions and be in possession of a clean driving licence.

Financial Package
